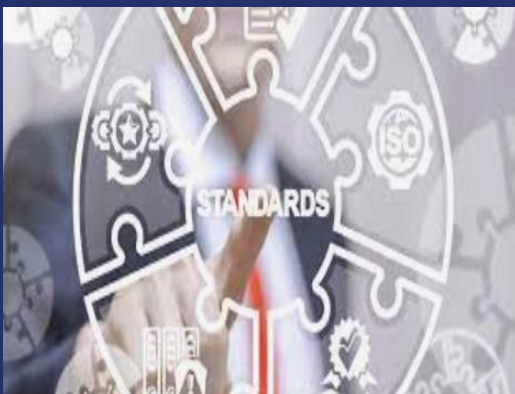
Greener Outlook:

16 June 2022 - On Tuesday 14th June 2022, the Security Industry Authority (SIA) prosecuted a Belfast man at Laganside Magistrates' Court for providing false information and failing to comply with the Private Security Industry Act.

23 May 2022 - Aylesbury Company Director prosecuted for unlicensed security at the Isle of Wight Festival. On Friday 13th May, a company director pleaded guilty at Milton Keynes Magistrates' Court for supplying a man who attempted to use a counterfeit licence.
